On measures to prevent the spread of the coronavirus infection in MAI dormitories

For the purpose of preventing the spread of the coronavirus infection in MAI dormitories, in compliance with the Recommendations of the Ministry of Education and Science of the Russian Federation on the organization of dormitory operation in the framework of realizing the order of the Ministry of Education and Science of the Russian Federation dated March 19, 2020 No. 453 "On operation of dormitories, hotels, health resorts, boarding houses, recreation centers and other seats of organizations subordinate to the Ministry of Education and Science of the Russian Federation in the context of preventing the spread of the coronavirus infection (COVID-19) on the territory of the Russian Federation", in addition to the Statute of the Moscow Aviation Institute (National Research University) Campus, as approved by the MAI Order dated 17.08.2018 No. 697, and the Moscow Aviation Institute (National Research University) Campus Internal Regulations, as approved by the MAI Order dated 17.08.2018 No. 698.

I HEREBY ORDER:

- 1. Until the normalization of the epidemiological situation, to instate the following living policies for students staying at MAI dormitories:
- 1.1. If a student temporarily leaves the dormitory for the period of distance learning or the period of an individual education plan, they are obliged to notify the Dormitory Supervisor in writing or by email, stating the date of departure, the expected return date, and the destination, attaching confirmation documents (travel or other documents) and listing a contact number and email.
- 1.2. If a student temporarily leaves the dormitory, they are strongly advised to return to the dormitory only at the start of intramural studies.
- 1.3. Those students who staying in MAI dormitory and are temporary absent at the dormitory (two or more days in a row), i.e. returns to the dormitory before offline educational process starts, are subject to medical examination at MAI health care center with the following isolation for 14 days from the day of moving in.

- 2. Head of the Department for the Development and Operation of the Social Residential Complex Olga Baglyukova shall:
- 2.1. provide medical supervision of the students, defined by the Clause 1.3 of this Order, within 14 days from the date of the relevant medical examination.
- 2.2. in case of receiving information about interaction between a student who stays in MAI dormitory and a person who is diagnosed with coronavirus infection COVID-19, provide isolation for the abovementioned student and the others who live in MAI dormitory during the period determined by the Order of the Chief State Sanitary Physician.
- 3. I undertake the execution control of this Order.
